## **MINIMUM QUANTITIES**

### **STANDARD PRINTING**

\$75.00 minimum order. No minimum quantity. Individual designs on the same order cannot be combined for quantity pricing.

### **WATER BASED & DISCHARGE PRINTING**

\$250.00 minimum order with a minimum quantity of 72 pieces for 1-color or 144 pieces for 2+ colors. Individual designs on the same order cannot be combined for quantity pricing.

### **ALL-OVER PRINTING & BELT PRINTING**

\$500.00 minimum order with a quantity minimum of 144 pieces. Individual designs on the same order cannot be combined for quantity pricing.



### **LEAD TIME**

Standard lead time on orders is generally 3-7 business days from art approval with product in warehouse, however, lead time can vary based on production schedule. If you require a specific in-hands date for your job, please specify at the time the order is placed. Rush projects will be accommodated if possible for an additional fee.

### **ARTWORK**

All art files submitted to PXP must be vector or raster art. To upload art files to PXP, please [Click Here](#).

#### **VECTOR ART**

Please submit artwork in Adobe Illustrator vector format. Convert all text to outlines. Please save as an EPS or AI file. Embed PMS colors when possible. If a placed/imported Adobe Photoshop type image is necessary, that original file should be included. The Photoshop file (TIF or JPG) should be at least 300 dpi resolution or higher with the art to size.

#### **RASTER ART**

Please submit artwork in PSD, TIF or JPG formats. Image should be at least 300 dpi resolution or higher with the art to size. Layered PSD files are strongly preferred. Files must vector art as either a .eps, .psd or .pdf.

All designs either supplied or created by PXP Art Department will be set to a proof for approval. Please pay specific attention to imprint colors, spelling, location, and size. NO orders will go into production without written/email approval of art proof.

Errors made with approved art proof will not be the responsibility of PXP.

Artwork changes made within 24 hours of scheduled production time will be subject to a designated rush charge.



## **RETURNS**

Returns for defective product are not accepted without prior written authorization for PXP. All requests for a refund or return must be made in writing within 10 days from delivery.

## **CANCELLATIONS**

All cancellations must be confirmed in writing. All costs incurred prior to cancellation will be billed. Orders that have already reached our screen making department cannot be cancelled.
